Technical Specifications:

1. Competitive offers are invited from the reputed manufacturers / dealers / service providers **having their registered / branch office in Lucknow.**
2. Vendor shall be registered in GST.
3. Firm/agency/contractor should have be more than of 03 (three) years of experience of rendering their services of maintenance and service of Online/Offline UPS up to 30kva and batteries in any Govt./Semi Govt. organizations. It should be supported by proper order copies. A list of their clients should be enclosed with proper proof.
4. Vendor/firm/agency shall provide proof of maintaining online UPS of different makes up to 30KVA rating. (Attach order copy as a proof).
5. Vendor shall provide 02 or more order copies of 3.0 lakhs and above for CMC of online UPS system of different makes from any Govt./Semi Govt. organizations for atleast two consecutive years in last 05 years.
6. Vendor should provide 02 or more satisfactory performance certificate of CMC services from existing customers in last 02 years from any Govt./Semi Govt. organizations.
7. Firms should have their own well established repairing centre of UPS, ware house and experienced service engineers/technicians.
8. Clear pictures/images of service engineers/technicians engaged at service/repairing centre(s) of UPS at Lucknow. The physical visit of service centre by CBMR team may organize, if require.
9. Vendor should provide the detailed list of engineers in his service team with their contact number & official e-mail id.

Terms & conditions should be compiled with while submitting the tender

The essential terms & conditions required for CMC (service with spares) of UPS are as under: -

1. **The tender will be accepted by speed post / regd. post / courier only** in the office of Centre of Biomedical Research (CBMR), SGPGI Campus, Raebareli Road, Lucknow - 226014 (UP), under the sealed cover failing which the tender shall be disqualified.
2. **L-1 will be decided on the basis of lowest quoting bid on whole.**
3. The charges for CMC (service with spares) for above listed UPS should be quoted separately. In addition to this, the **rates for batteries should also be quoted** separately in the Price Bid with the **validity of minimum one year** for rate contract.
4. The cost of CMC shall cover repair & service with replacement of all parts. However, the CMC does not include cost of replacement of batteries for UPS(s).
5. The service personnel shall rectify the complaints received from the office on the same day. If necessary, they will be required to stay back after office hours and even on holidays too, to attend any emergency work.
6. If the faulty components / UPS(s) are not rectified within the same working day, necessary standby components / UPS(s) of the same KVA rating shall be

provided in the following day for smooth functioning of office work. If the original equipment is not rectified till the expiry of contract, either the cost of repair of the equipment be borne by the contractor or the stand by supplied by the contractor not be reclaimed.

7. Preventive maintenance such as checking the general performance of UPS systems and DC standby sources, filling of distilled water and application of white petroleum jelly for non-sealed type UPS, etc., shall be done at site twice in a month.
8. The successful bidder should maintain Log Registers / Service Reports of all calls attended / pending issues, preventive maintenance records and details of all replacement of spares. A separate log book shall be maintained for preventive maintenance.
9. No component(s) / Spare(s) / computer(s) shall be removed without informing the competent authority.
10. Payments will be made on quarterly basis only after satisfactory completion of each quarter.
11. Since all maintenance / installation are within CBMR premises, no TA/DA any other allowances will be paid to the staff of the contractor.
12. **Time Period:- The period for the work (CMC) will be three (03) years from the date of award** and is liable to be terminated at any time by giving notice of one month by either party.
13. The period of work (CMC) shall be extendable for a period of one more year at the same rate, terms & conditions only, if the services of the vendor are found satisfactory during the normal period of contract.
14. The firm will provide atleast 04 (four) preventive maintenance in a year for all the UPS installed in the Centre.
15. The personnel/staff responsible for attending to the complaints should be stationed and available within the Lucknow.
16. The offer should be sent to the office of CBMR in sealed cover super-scribed as "Tender for CMC of UPS".
17. Offer should be made in two-bid system i.e. Technical Bid and Price Bid. The Price Bid of those vendors who qualify under technical bid will be opened only.
18. The charges for CMC & Batteries of UPS as required should be quoted separately in Price Bid only.
19. The prices should be on F.O.R. CBMR basis inclusive of all levies and duties wherever applicable which should be indicated clearly. The rates of GST must be clearly indicated wherever chargeable.
20. EMD, Income Tax / GST Clearance Certificate and all other information required as per our tender documents, must be furnished with technical bid only.

21. Name of Bid, Tender Number with due date must be mentioned at the top of the envelope.
22. The tender terms & conditions be clearly typed or legibly written giving the full name and address of the tenderers. The tenderers should quote in figures as well as in words the rates and amount tendered by him/them. Alteration, if any unless legibly attested by the tenderers, with their full signature, shall invalidate the tender. The tender should be signed by the tenderers himself/themselves.
23. The tenderers should take care that the rates and amounts are written in such a way that interpolation is not possible. No blank space should be left, which would otherwise make the tender liable for rejection.
24. The tenderer submitting his tender would be deemed to have considered and accepted all the terms and conditions. No Enquiries, verbal or written shall be entertained in respect of acceptance or rejection of the tender.
25. The Centre reserves the right to cancel/reject in full or any part of the tender which generally do not fulfill the conditions stipulated in the tender without assigning any reason.
26. Any action on the part of the tenderer to influence anybody of the Centre will make his tender liable to rejection.
27. The tenderers shall submit the offer with in original copy of the tender documents duly signed on each page. Item-wise rates indicating units can be offered on letter head of the firm.
28. The tenderers shall submit the required **tender fee (non refundable)** for **₹ 1,180.00** i.e. ₹ 1000.00 + ₹ 180.00 as GST @18% (One thousand only + One hundred eighty as GST@18%) **online in favour of Director, CBMR**, as per the details given in Clause no. 29 (A). The receipt/proof of online submission must be attached with first part i.e. Technical Bid.
29. Earnest Money Deposit (EMD)

- (C) Earnest Money be paid as per details mentioned above.
- (a) Non-compliance of terms & conditions of the tender and/or supply order may amount forfeiture of EMD.
 - (b) The EMD of unsuccessful bidder will be released immediately once the tender is finalized.
 - (c) The EMD of successful bidder will be released after execution of supply order satisfactorily.
 - (d) EMD will be refunded without any interest whenever it is returned.**
30. The offer of the tenders shall remain valid for a period of 180 days from the date of opening of the tender.
31. Payments shall be released on **quarterly basis** on satisfactory performance.
32. All disputes and question, if any arise between the Centre and the bidder out of or in connection with the terms and conditions contained herein or as to the construction of application thereof, or the respective rights and obligations of the parties there under or as to any clause or thing herein contained or by reason of the operation and maintenance or failure or as to any other matter in any way relating to these presents shall be referred to the President of the Centre/Chief Secretary of the U.P. Govt. or his nominee. The decision of the sole arbitrator shall be final and binding upon both parties and subject to adjudication of Lucknow Court. Place for arbitration shall be at Lucknow (U.P.). Venue of such arbitration proceedings shall be the Centre. Arbitration and conciliation Act 1996 and rules made there under shall be applied to the proceedings under this clause.
33. Tenderers hereby agree to all terms and conditions stipulated in NIT and undertake to sign the Contract within the given days from the date of order failing which Security shall be liable to forfeit.
34. The contractor will ensure a proper service as per our requirement from time to time, against the agreement clause as per the terms & conditions agreed under negotiations would be provided at our Centre without fail. Any negligence on this account shall be the sole responsibility of contractor and the liability for compensation will be fixed up by the Centre of Biomedical Research, Lucknow.
